Waiver, Release and Indemnity Agreement

In consideration of the acceptance of my application for membership in New BraunFit, I hereby WAIVE, RELEASE AND DISCHARGE McKenna System, its subsidiaries and affiliates, (hereinafter "McKenna System") from any and all claims, demands, actions, or right of action for damages, for personal injury or death that I may have or that may subsequently accrue to me of whatsoever kind or nature in law or in equity, as a result of my participation in any athletic activity and use of the facilities or as a result of any occurrence at the McKenna System on 801 West San Antonio Avenue in New Braunfels, Texas. This release is intended to discharge in advance the owners and administrators of McKenna System and their respective agents, employees, and assigns from and against any and all liability arising out of my participation in activities at New BraunFit, now or in the future, even though that liability may arise out of negligence or carelessness on the part of the persons or entities mentioned above.

I understand that serious accidents may occasionally occur in the type of activities in which I may participate at New BraunFit and personal injury may occur. Knowing the risks associated with participating in such activities, I agree to assume the risks, accept full responsibility for such risks and to release and to hold harmless all the persons or entities mentioned above who through negligence or carelessness might otherwise be liable to me or to my heirs or assigns for damages.

It is further understood and agreed that the above release, waiver and assumption of risks is to be binding on my heirs and assigns.

I agree to indemnify and to hold harmless, the releases and each of them from any loss, liability, damage or cost that they might incur due to my participation as a member of New BraunFit, whether caused by the negligence of releases or otherwise.

The undersigned expressly agrees that the above release, waiver and indemnity agreement is intended to be as broad and inclusive as is permitted by the laws of the State of Texas, and if any portion of the agreement is held to be invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

The undersigned has read and voluntarily signs the release and waiver of liability, fully understands its contents and further agrees that no oral representations, statements or inducements apart from the above written agreement have been made. The terms of this release are contractual and not a mere recital.

YOUR MEMBERSHIP IN NEWBRAUNFIT DOES NOT IN ANY WAY INCLUDE OR GUARANTEE TO YOU ANY INSURANCE COVERAGE OF ANY KIND.

Member Services Information

Membership: A nonrefundable/nontransferable annual membership fee to New BraunFit is due and payable before taking part in any gym activities/programs.

Information Center: The New BraunFit schedule can be picked up at the front desk or reviewed online at www.newbraunfit.org

Personal Data: Please keep the front desk informed of changes in address, telephone number, etc. Change of Status forms are available at the front desk.

Membership Policy

- Each member will receive a membership card. You must check-in with the Front Desk Attendant with your card each time you come in for an activity.
- Lost or damaged cards will be replaced for a fee of \$5.00.
- All fees are subject to change. Members will be notified at least 30 days prior to any changes taking effect.
- New BraunFit Administration reserves the right to revoke any membership with or without cause and at any time without notice.

Policies for Facility Use

- New BraunFit maintains a Lost and Found; however, New BraunFit is not responsible for lost or stolen articles.
- New BraunFit and the McKenna System building is a smoke-free facility. Smoking is not allowed in the facility or on its premises.
- Profanity or abusive language is not allowed.
- No food or alcoholic beverages may be brought into the gym or on its premises.
- Water bottles with spill proof lids are allowed in the bleacher area of the gym.
- Appropriate athletic shoes must be worn.
- T-shirts or tank tops must be worn at all times.
- No shirts expressing profane or derogatory comments are allowed.
- Personal equipment (basketballs, volleyballs, footballs, etc) are prohibited.
- No dunking or hanging on the basketball rims
- Do not lean on or pull on divider curtains.
- Behavior deemed inappropriate by the New BraunFit staff will be grounds for immediate expulsion from the gym. Continued inappropriate behavior will result in loss of membership privileges. (Inappropriate behavior includes but is not limited to unwillingness to follow rules, harassment of other members and staff, creating an unsafe environment, etc).
- Courts may be broken down into half court games in order to accommodate more people. This decision will be made by the New BraunFit staff.
- "Open Gym" is open to all ages. Children age nine and under must be supervised by an adult, age 18+ at all times.
- No loitering in the reception area or in front of the building.
- No sitting on the ledges in front of the building.
- Members of New BraunFit must be engaged and participating in programs/activities to remain on the premises.
